1.0 CONFIRMATION OF THE AGENDA

Mr. Bull made a motion to add a new boxing event application and add it as item CSC2025-11 to the agenda. CARRIED.

2.0 CONFIRMATION OF THE MINUTES

Mr. Bull made a motion to approve the March 19, 2025 and April 4, 2025 meeting minutes of the Calgary Combative Sports Commission. CARRIED.

3.1 YEAR-TO-DATE REVENUE AND EXPENDITURES UPDATE

Mr. Pallister reported the year-to-date revenue at \$18,000.00, the expenses at \$33,113.00, and the reserve balance is at \$50,689.48. The Commission accepted the report for information.
