Mr. Moore made a motion to approve the mixed martial arts event application promoted by Unified MMA at the BMO Centre on February 28, 2026, with the conditions that the weigh-in start after 5:00 pm, there only be between 12-14 bouts, and the event be completed within 5 hours. CARRIED.

5.8 (CSC2025-18) CHAIRPERSON'S UPDATE

The Commission discussed the recent inquiry on the judges score cards from the 2012 and 2018 UFC events. Mr. Briegel will speak to the FOIP lawyer before releasing any information to the public.

Mr. Briegel and Mr. Madigan will be attending the Audit Committee meeting next week to present on the Combative Sports audit.
